#### General statement

The European Law Students' Association (hereinafter ELSA) fully respects your right to privacy, and will not collect, process or publish any personal data about you other than as set out in this privacy policy. Any personal information, which you provide to ELSA will be treated with the highest standards of security and confidentiality, strictly in accordance with applicable data protection laws.

## What is the purpose of the data collection?

ELSA International needs to collect the data from the ELSA Legal Research Group application form in order to be able to successfully administrate an International ELSA Legal Research Group.

ELSA International fully and exclusively administrates International ELSA Legal Research Group, which means collects all the applications, i.e. the data from the above-mentioned application form. The necessary data from the application form are forwarded to the applicant's National ELSA Group and the National Coordinator of the International ELSA Legal Research Group in the respective country.

The aim of ELSA Legal Research Group is for ELSA International to gather groups of law students and young lawyers from each National ELSA Group who will conduct research on a specific topic of law for the respective ELSA Legal Research Group. In order for ELSA International to be able to complete the selection of participants of the International Legal Research Group, they need the data from the ELSA Legal Research Group application form.

Certain data may be used for the creation of statistical data, which will always be generalised numbers only, completely anonymised.

#### What personal data does ELSA collect in application forms?

ELSA International collects only the data that are needed to fulfil the purpose of it being collected, which is the data that are relevant for ELSA International to make a decision on the selection of participants for the respective International ELSA Legal Research Group. The necessary data collected are visible in the above-mentioned application form.

### Who has access to your information and to whom is it disclosed?

After ELSA International collects the data, ELSA International will disclose the data of the applicants to ELSA International's Legal Research Group Team. The purpose of this disclosure is for the ELSA Legal Research Group Team to do the pre-selection of the participants based on the data from the application forms and afterwards to forward this information to ELSA International. ELSA International makes the final selection using the data collected. If the data are incorrect, ELSA International maintains the right to modify or delete the data.

ELSA International discloses the names of the applicants to the respective National ELSA Group and the National Coordinator. The purpose of this disclosure is to select the participants of the International ELSA Legal Research Group in the respective country.

Some of the National ELSA Groups, and therefore some of the National Coordinators, are located outside of the European Union, in a country deemed not to offer a similar level of data protection as within the European Union.

## How long do we keep your data?

The data will be kept for as long as it is necessary for the administration of the International ELSA Legal Research Group, i.e. as long as there is a need to disclose this data to ELSA International's Legal Research Group Team for them to fulfil the purposes stated above. However, that period is never longer than one year from when the data are submitted.

# How can you access your personal data, verify its accuracy and, if necessary, correct it?

In accordance with applicable data protection laws, you have a right to access your personal data, and request correction of inaccurate, or deletion of irrelevant personal data. When you submit your application, an e-mail confirmation is sent to your e-mail address.
